CONSEQUENCES OF PLEA OF GUILTY OR NO CONTEST

- 15. I have read and understood the above charts which list the minimum and maximum penalties for the offense(s) I am charged with.
- 16. I understand that in addition to the fine, the Court will add assessments which will significantly increase the amount I must pay.
