PLEASE READ CAREFULLY BEFORE YOUR APPOINTMENT

What to bring to your appointment or walk-in visit

- Valid ID.
- Court Case number (if there's a case already filed).
- All case-related documents, including any court orders you wish to modify.
- If filing for divorce or legal separation: Your marriage certificate (or a copy of it).
- If children are involved (new case or final judgment): Children's birth certificates (or copies of them).
- For final judgment assistance:
 - Blank No. 10 (Letter Size) envelopes
 - Forever stamps

IMPORTANT: If it is a new case, make sure to use complete legal names for all parties and children. Do not leave out or abbreviate middle names.
