WHAT SHOULD I HAVE AVAILABLE?

- Your government issued identification
- Full names, birth dates, and information of the parties and minor children involved
- Case number
- Pens (black or blue)
- If needed, reading glasses
- Any documents related to your case

CASE TYPES SHLAC HELPS WITH

- Eviction
- Misdemeanor Expungements
- Conservatorships and Guardianship—**Person ONLY**
- Step-Parent Adoption (initial forms only)
- Adult Adoption
- Civil Harassment & Elder Abuse Restraining Orders
- Collection Defense
- Judgment Enforcement
- Name Change
- Name & Gender Change

WHERE DO I FILE MY FORMS?

If your forms are complete and ready to file, you can file them with the Clerk of the Court. If you want a file-stamped copy returned to you, you will need the original and at least one copy of each form. The Clerk's offices are:

- **Civil Clerk's Office** – Room 210 – Ventura Courthouse – Civil forms (include evictions)
- **Family Law Clerk's Office** – Room 208 – Ventura Courthouse – ALL restraining order and family law forms
- **Juvenile/Probate Clerk's Office** – Room 122 – Oxnard Courthouse – Guardianship, conservatorship, juvenile and probate forms
